15 April 2018 The Third Sunday of Easter



We continue to think about the Resurrection this week. three different from perspectives: the Gospel gives us another story of Jesus appearing to his disciples - this time the beautiful story of the

meeting in Jerusalem, when Jesus proves he is alive and no ghost by eating some grilled fish: he reminds the disciples that he suffered and rose so the repentance for the forgiveness of sins could be preached to the whole world. The first reading shows us Saint Peter doing just that, as he addresses the crowd in Jerusalem on the day of Pentecost: he takes them through recent events (fifty days earlier), highlighting the important point, that he and the disciples can witness to the raising of Jesus from the dead, and calling them to repent and turn to God, so that your sins may be wiped out. The second reading brings this into our lives: the resurrection is not just a historical event, which we remember. By baptism (which we renewed at Easter) we become part of Jesus in his dying and his rising, as he becomes the sacrifice that takes our sins away. So all that Saint John tells us about the commandments and avoiding sin, is our way of living the Resurrection.

Marriage Matters: Let peace reign in our hearts: There are times in life, as couples, when the demands of work, concerns about money and care of the children can seem overwhelming. In times like these let's acknowledge each other, take time out to clarify the issues and remind ourselves of the words of Jesus to the Apostles when they thought it was all over, "Peace be with you!"

Think Vocation: Today we hear that St Peter the first Pope bravely preaches the Easter message that Christ is Risen. The present Holy Father is the successor to St Peter and is the leader of the universal Church. As we receive the Eucharist today let us become aware of our place in the universal Church and let us always have a "world" dimension to our understanding of what it is to be Roman Catholic.

Parish Finances

Arising from discussions with the Parish Enabling Team (PET) over the past few months, and wishing to satisfy the requirement of Canon Law, I have now established a Parish Finance Committee which held its inaugural meeting on Wednesday evening. This committee exists to help the parish priest administer the goods of the parish, through the expertise of its members. I am grateful that we have a mix of people with financial, legal and business experience: Greg French, John Howarth, Marie Meagher, Chris Molyneux and Kathryn Wilkinson (along with the parish clergy). Normally this committee would meet quarterly to consider parish finances over the previous three months and help finalise the accounts for submission to the diocese each January. However, it can meet more often if required or desired. The committee also has responsibility for parish property in terms of the contents of our buildings. Again through discussions with the PET, I am establishing a separate Parish Property Team to look after the maintenance and development side of our buildings and sites (and will report on that when it is set up).

Here is a summary of the accounts submitted to the diocese in January. Although our new parish came into being in September 2017, we were asked to report separately on all three for the whole of the financial year but for 2018 we will have one set of accounts for Corpus Christi (and a residual account for St Columba until the disposal or development of the building and site are resolved).
